第一条 本附加险合同须附加于各种责任保险(以下简称"主合同")项下。

第二条本附加险合同与主合同相抵触之处,以本附加险合同为准。本附加险合同未约定事项,以主合同为准。主合同效力终止,本附加险合同效力亦同时终止;主合同无效,本附加险合同亦无效。

传染性海绵状脑病包括但不限于牛海绵状脑病、慢性消耗病、克雅氏病、新变种克雅 氏病、羊瘙痒病或传染性水貂脑病。

本除外条款包括但不限于任何与传染性海绵状脑病相关的,或由其造成、引起或加速的损失、费用或开支。本除外条款也适用于因此而给予或应该给予的相关监督、指示、建议、警告或意见造成或引起的费用。

## Zhongan Online P&C Insurance Co., Ltd. Transmissible Spongiform Encephalopathy Exclusion

**Article 1** This endorsement is issued as part of the main policy.

**Article 2** In case of any discrepancy or contradiction between this endorsement the main policy, this endorsement shall prevail.

Except as it expressly states, this endorsement does not (1) modify any of the terms and c onditions of the main policy, (2) modify the insurance period of the main policy.

If the main policy is invalid, this endorsement is invalid.

Anything modifies the terms and conditions of this endorsement shall be expressed in writing.

Article 3 It is hereby understood and agreed that the main contract does not apply to "bodily injury", "property damage", "personal and advertising injury" or any other loss, cost or expense, including, but not limited to inspection costs, surveillance costs, slaughter costs and costs or expenses related to, arising from or associated with clean-up, remediation, containment, removal or abatement, caused directly or indirectly, in whole or in part, by any form of Transmissible Spongiform Encephalopathy (TSE), including, but not limited to Bovine Spongiform Encephalopathy (BSE), Chronic Wasting Disease (CWD), Creutzfeldt-Jakob Disease, New Variant Creutzfeldt-Jakob Disease (nv-CJD), Scrapie or Transmissible Mink Encephalopathy, regardless of any other cause, event, material or product that contributed concurrently or in any sequence to that bodily injury, property damage, personal and advertising injury, loss, cost or expense.

This exclusions includes but is not limited to any loss, cost or expense which is related to or contributed to, caused or accelerated by or results from any form of TSE, or any supervision, instructions, recommendations, warnings or advice given or which should have been given in connection therewith.
